### THE DISCOUNT

The courses eligible for a discount are identified at the discretion of the Professional Studies & Industry Training (ProSIT) department. Please note that Camosun staff are eligible for the discount 3 days prior to the start of the course or earlier depending on if the course has met minimal enrolments.

## **ADDITIONAL FUNDING**

#### **CCFA Employees**

Any Leadership Development Certificate (LDCT) courses are preapproved to have 100% tuition reimbursed by the CCFA as professional development (PD). Fill out the CCFA preapproved <u>PD form</u> and send it to the CCFA office for confirmation prior to registering. Once you have confirmation, register and pre-pay for each course and then submit your form and receipt to the CCFA Office. You can register anytime for these courses.

#### **CUPE & EXEMPT Employees**

Apply for reimbursement of ProSIT course costs related to educational and/or professional development goals. Visit the <u>PD Intranet page</u> to learn more and find the forms.



#### Terms and Conditions

In consultation with HR, a 50% discount on tuition is applied to eligible ProSIT courses under the following terms:

- The registrant is a current continuing or term faculty (CCFA/BCGEU), or a full or part-time CUPE or Exempt employee. Retired, contracted, and casual employees are not eligible for this discount.
- The course must have reached minimum enrolment and have a vacant seat. If a waitlist exists, seats must first be offered to those on the waitlist.
- Discounted registration begins once minimum seat requirements have been filled.
- The employee is responsible for the cost of textbooks, added certification fees and course supplies.
- The discount is not appicable if using StrongerBC future skills grant funding.
